#### <u>NEWS LETTER – 2019</u>

Mediation as an alternative dispute redressel process, is of recent origin in India. In 2007, the ISDLS, California under the aegis of the Hon'ble Supreme Court of India, spearheaded a pilot project at New Delhi and Bengaluru followed.

COURT ANNEXED MEDIATION was formally introduced at Bengaluru in 2007 as an initiative of the Hon'ble High Court of Karnataka. The then Chief Justice of the High Court of Karnataka, Hon'ble Mr.Justice Cyriac Joseph, visualized an Institution exclusively for Mediation at Bengaluru. Therefore, the 1<sup>st</sup> Batch of 12 advocates were trained in Mediation by the trainers of ISDLS in 2007. Mediations were conducted in the screne surroundings of the Karnataka Judicial Academy.

BMC has retained its focus on training and capacity building. Its trainers have trained Advocates and Judges in Mediation all over India. Trainers of BMC were invited to the Maldives to impart training. BMC has trained 16 sitting Judges of the Karnataka High Court till 2018. BMC has strength of 118 Mediators, while in the Districts the strength is 2006.

As per the resolution passed by the Board of Governors, BMC the following calendar of events has been fixed for the year 2019, commencing from January-2019 to December-2019 regarding conducting Refresher Training Programmes for Referral Judges in the state and also Mediators across the state.
