FROM THE EDITOR

Mediation as an alternate dispute redressal process, is of recent origin in India. In 2007, the ISDLS, California under the aegis of the Hon'ble Supreme Court of India, spearheaded a pilot project at New Delhi and Bengaluru followed.

Court Annexed Mediation was formally introduced at Bengaluru in 2007 as an initiative of the Hon'ble High Court of Karnataka. The then Chief Justice of the High Court of Karnataka, Hon'ble Mr.Justice Cyriac Joseph visualized an institution exclusively for Mediation at Bengaluru. Therefore, the first batch of 12 Advocates were trained in Mediation by Trainers of the ISDLS in 2007. Mediations were conducted in the serene surroundings of the Karnataka Judicial Academy

Realizing the need to institutionalize the process, Hon'ble Mr.Justice Cyriac Joseph established the Bangalore Mediation Centre (BMC) in 2007 under the aegis of the Hon'ble High Court of Karnataka. In nine years since its inception, BMC has evolved into a premier institution of excellence commanding an enviable reverence across the world. BMC stands as testimony to the vision and commitment of its Founder, Hon'ble Mr.Justice Cyriac Joseph. His dream of an enduring institution is today an irrefutable reality. BMC has been recognised across several countries as a premier institution in Mediation.

BMC has retained its focus on training and capacity building. Its trainers have trained Advocates and Judges in Mediation all over India. Trainers of BMC were invited to the Maldives to impart training. BMC has trained 9 sitting Judges of the Karnataka High Court in 2011.

BMC has the distinction of having mediated over 40837 cases since inception and having settled over 26333 cases. Resolved cases represent a wide spectrum - civil suits, matrimonial cases, money recovery suits, guardianship disputes, child custody cases, writ petitions, SCLAPs, RFAs, MFAs, IPR related suits and suits relating to cross-border commercial transactions. In over 308 divorce petitions filed under various statutes, Mediation has succeeded in reuniting the warring couples. It is a tribute to the skills of the Mediators of BMC.

BMC is located in a well maintained building with 16 Mediation rooms, two spacious waiting halls, clean toilets and a canteen that serves wholesome food. Dedicated staff ensure an efficient administration. BMC, therefore, provides to litigants a friendly and cordial environment which in itself goes a long way to ease tensions, while preparing the ground for mediation.

BMC has a strength of 113 Mediators, while in the Districts the strength is 1951.

BMC has been transformed from a fledgling institution to a position of prominence in nine years. BMC conveys its deep sense of appreciation to its Mediators and staff for their effort and dedication in making BMC a nationally recognised institution of quality. BMC conveys its gratitude to its Founder, Hon'ble Mr.Justice Cyriac Joseph whose guidance, support and encouragement will always be cherished. The Board of Governors have contributed in great measure to the growth of BMC and BMC expresses its sincere gratitude to them.

STATE LEVEL WORKSHOP ON MEDIATION, BENGALURU



A State Level Workshop on Mediation and Orientation Programme for Mediators was organised by the BMC in collaboration with the Karnataka State Legal Services Authority on 27.2.2016 at Dr.Ambedkar Bhawan, Bengaluru. 417 Mediators from 27 districts of Karnataka and Mediators of BMC participated. The State Level Workshop was the first of its kind in the country.

Hon'ble Mr. Justice Mohan M. Shantanagoudar,



the then President, BMC welcomed the guests and gave an introductory address. The workshop was inaugurated by Hon'ble Mr.Justice Madan B. Lokur, Judge, Supreme Court of India and Chairman, MCPC. In his address, he emphasized the need to ensure the growth of Mediation as an alternative dispute resolution mechanism, particularly in the Districts. He opined that adherence to a strict code of ethics was critical. Hon'ble Mr.Justice Subhro Kamal Mukherjee, Chief Justice High Court of Karnataka and Patron-in-Chief delivered the Presidential address.

The first business session with the theme "Key to Structured Mediation – the Opening Statement" was chaired by Hon'ble Mr.Justice Aravind Kumar, Member, Board of Governors, BMC, who commenced the session with introductory remarks. To reiterate the importance of and need for an effective opening statement, presentations were made by Mr.Shiv Kumar, Master Trainer, BMC on the "structure and stages of Mediation;" by Smt. Susheela S, Master

Trainer, BMC on the "importance of an opening statement" and by Smt. Geetha Devi Papanna M.P. Trainer, BMC on the "contents of the opening statement." The session concluded with a panel discussion on the subject.

The second business session with the theme "Core Concepts of Mediation" was chaired by Hon'ble Mr.Justice K.N.Phaneendra, Judge, High Court of Karnataka, who commenced the session with

an introduction to some of the core concepts of Mediation. These concepts were emphasized through presentations made by Mr. Humayun M.A. Trainer, BMC on the "purpose of joint and private sessions and need for effective communication;" by Mr. Prasad Subbanna, Master Trainer and Coordinator, BMC, on "negotiations and determining strategies and effective communic ation," and by Smt. Shobha Patil, Master Trainer and Coordinator. BMC on evaluation of "Success in Mediation". The session concluded with a panel discussion on the subject.

A panel discussion (open house) was held between 3 and 4pm. Members of the panel were

The Anchors were Mr.Prasad Subbanna and Mr.Bharat Mehta.

Several issues relating to Mediation, like lack of referrals, fee structure, lack of infrastructure, logistics issues, particularly in districts and lack of adequate manpower were discussed. Suggestions and queries received and collated from District Mediation Centres, were responded to by the panel. The consensus was that if appropriate measures were taken, a higher rate of referrals and a better quality of Mediation would ensue. Relevant issues relating to the manner of making references, the nature of cases to be referred, procedures to be followed etc., were discussed at length. Hon'ble Mr. Justice Mohan M. Shantanagoudar informed the participants that a circular had been issued by the High Court of

Karnataka requiring all Courts to refer at least 4 cases in a month to Mediation.

The panel discussion was followed by the valedictory function. Hon'ble Mr. Justice N.Kumar, Judge,(Retd.) High Court of Karnataka was the Chief Guest. Speaking on the occasion, Hon'ble Mr. Justice N.Kumar asserted that a settlement in Mediation should be the result of intense efforts by a Mediator and not due to a mere change in circumstances of the parties.



At the valedictory function Awards and Certificates were given away by Hon'ble Mr.Justice Madan B. Lokur and Hon'ble Mr.Justice N.Kumar to 10 Mediators of BMC who had mediated in the largest number of cases. The Awardees were:

In his address Hon'ble Mr.Justice Madan Lokur appreciated the excellent working of BMC but observed that the success rate at the district centres was comparatively low. He expressed the hope that Mediation in Karnataka would register an impressive growth within a year.

REGIONAL CONFERENCE ON MEDIATION, CHENNAI



A Regional Conference on Mediation was organized by the High Court of Tamil Nadu and the Tamil Nadu Mediation and Conciliation Centre, on 9th January 2016 at Chennai.

The object of the Conference was to discuss:

- (i) challenges in implementation & management of Mediation activities:
- (ii) solutions to overcome challenges faced in implementation of the Mediation Programme; and
- (iii) implementation of a plan for the year 2016-17.

The Inaugural Address on 9.1.2016 was delivered by Hon'ble Mr.Justice F.M.Ibrahim Kalifulla, Judge, Supreme Court of India. The opening address was delivered by Hon'ble Mr.Justice Sanjay

Kishan Kaul, Chief Justice, High Court of Tamil Nadu, while a Special Address was delivered by Hon'ble Mr.Justice Madan B.Lokur, Judge, Supreme Court of India and Member, Mediation and Conciliation Project Committee.

The first business session on 9.1.2016 comprised presentations by the High Courts of Kerala, Tamil Nadu, Karnataka, Mumbai and Chhatisgarh followed by open house discussions. The presentations related to the challenges in implementation and management of Mediation activities, solutions to overcome challenges in implementation and projected plans for 2016-17. Hon'ble Mr.Justice Mohan M. Shantanagoudar made a presentation on behalf of the High Court of Karnataka. He highlighted the success rate of BMC and explained measures that had been implemented to train Mediators in all the Districts of Karnataka. He noted that Karnataka had 2027 Mediators. He emphasized that 40 hours training in Mediation had been imparted to selected Advocates in all the Districts of Karnataka. Subsequent to the presentations, delegates from each State convened in a Break Out Group to discuss ways and means to promote Mediation and to counter challenges to growth of Mediation.

The second business session on 10.1.2016 witnessed Power point Presentations by each Break Out Group. Several challenges ranging from lack of infrastructure, lack of referrals to inadequate

remuneration and related issues were identified and debated.

The Break Out Group from Karnataka recommended multifaceted programmes to popularize Mediation at grass-root levels and suggested the use of local cultural and social media alongwith use of technology. The Group suggested that a survey be conducted by a professional agency to determine the existing reach and awareness of Mediation to be followed by a sustained campaign to create nationwide awareness about benefits of Mediation. Using a "brand ambassador" was recommended. Developing a "Best Practices Manual"

was suggested. It was recommended that a well structured course on "Mediation Advocacy" be designed in collaboration with Bar Council/s and Judicial Academies in the country. The Group explained the need for a uniform protocol in cases referred to Mediation.

Both business sessions were in the presence of Hon'ble Mr.Justice Madan B.Lokur and Mr. P.P.Rao, Senior Advocate, Supreme Court of India and Member of the MCPC.

The Conference concluded with a valedictory function on 10.1.2016.

ORIENTATION PROGRAM FOR JUDICIAL OFFICERS, BENGALURU ZONE



An Orientation program on Mediation was organised for judicial officers on 27.3.2016 at the Golden Jubilee Hall, High Court of Karnataka and was attended by over 271 serving Judicial Officers from Bengaluru

He emphasized the importance of addressing "interests" of parties rather than legal positions that are usually adopted by litigants.

The business sessions was followed by an interactive session with a panel that comprised:

emphasized the need for Mediation to be understood by all sections of society and exhorted Judicial Officers to refer more cases to Mediation. Hon'ble Mr.Justice Mohan M.Shantanagoudar, Judge, High Court of Karnataka and the then President, Board of Governors, BMC presided over the function.

In the first business session Hon'ble Mr.Justice Aravind Kumar, Judge, High Court of Karnataka and Member Board of Governors, BMC, addressed the participants on the role of Referral Judges and explained their role and responsibility in referring cases to Mediation.

The second business session was addressed

by Hon'ble Mr.Justice K.N. Phaneendra, Judge, High Court of Karnataka. He explained the contents of Section 89 of the Code of Civil Procedure and gave a basic insight into the process of Mediation with particular reference to the kinds of cases that could be referred to Mediation.

The third business session was addressed by Ms.Geeta Devi Papanna, Mediator and Trainer, BMC, who outlined Hon'ble Mr.Justice Mohan M. Shantanagoudar Hon'ble Mr.Justice S.Abdul Nazeer Hon'ble Mr.Justice Aravind Kumar Hon'ble Mr.Justice Ravi Malimath Ms.Geeta Devi Papanna

Several issues arising out of the business sessions and relating to the process of referring cases to Mediation, followup and monitoring the progress of Mediation in individual cases were aired and discussed.

Under the aegis of the Mediation and Conciliation Project Committee (MCPC) of the Supreme Court of India a three day capsule training programme was conducted at the Bengaluru Mediation Centre between 14th and 16th April 2016. The training was guided by Ms.Shalinder Kaur, DHJS, Delhi and Ms.Poonam Mendiratta, Trainer, Delhi Mediation Centre. 37 Trainers of BMC participated.

The objectives of the capsule training were two fold, first to be a refresher course for the participants and second to identify potential trainers to be empanelled as trainers of MCPC.

The event witnessed 15 minute presentations by each of the participants on different aspects of Mediation. Interactive sessions that followed each presentation witnessed intense discussions while role plays and the de briefing thereafter by Ms. Shalinder and Ms. Poonam provided new inputs relating to strategies that could be adopted in Mediation.

Presentation and interactive response skills of Trainers were evaluated by the Trainers from Delhi. The three day capsule training clearly established the need for periodic review of Mediation skills through continuing education or refresher courses.

Bangalore Mediation Centre conveys its sincere gratitude to Ms. Shalinder Kaur and Ms. Poonam Mendiratta for having devoted valuable time with our Mediators as also for their inputs which together was a learning experience for the participants.

40 HOURS TRAINING FOR JUDICIAL OFFICERS

A five day –40 hours training programme was organised by Bangalore Mediation Centre (BMC) at the Centre for 20 serving judicial Officers of Bengaluru and others Districts between 2.5.2006 and 6.5.2016.

OVERVIEW OF MEDIATION FOR COLLEGE STUDENTS

CONSULTING PSYCHOLOGIST AT BANGALORE MEDIATION CENTRE

The availability of a qualified Counsellor has proved to be a source of immense comfort and help to a large number of litigants involved in matrimonial conflict.

BMC is proud that it is the first and only Mediation Centre to provide such an in house facility.

PRE-LITIGATION DESK AT BANGALORE MEDIATION CENTRE

Consequent upon the judgment of the Hon'ble Supreme Court in K.Srinivas Rao v/s D.A.Deepa (2013) 5 SCC 226 which directed establishment of prelitigation Desks at each Mediation Centre, the BMC has set up a dedicated prelitigation Desk at its premises at Bengaluru. The Desk has been operational since 2014 and is manned by trained Mediators on a roster basis on six days of the week. Several cases relating to Section 498-A of the IPC, matrimonial conflicts and related issues have been mediated and successfully resolved.

GUEST LECTURE

"CROSSING BOUNDARIES THROUGH DIALOGUE"

On 25.7.2016 Ms. Ameya Kilara, a dual qualified Lawyer (UK and India) addressed Mediators at Bengaluru Mediation Centre (BMC) on "Crossing Boundaries Through Dialogue." She narrated her experiences in negotiating peace in Kashmir, as the Projects Manager, South Asia Programme of CONCILIATION RESOURCES, which is an independent peace building organisation working in eight conflict contexts globally. She explained the nature of conflict in Kashmir, and peace making efforts through Mediation and negotiation, particularly along the Line of Control. She emphasized that any peace making initiative recognised the fundamental concept of "possibilities" in the quest for solutions. 
